

REPORT OF THE BOARD

董事局報告書

The members of the Board are pleased to present the Annual Report, together with the audited statement of accounts for the year ended 31 March 2021.

West Kowloon Cultural District Authority

Pursuant to the WKCD Ordinance (Cap. 601), which took effect on 11 July 2008, WKCD was established to develop West Kowloon into an integrated arts and cultural district.

Board members

The members of the Board since 1 April 2020 and up to the date of this report are set out on pages 78 to 79.

Principal activities

The functions and objectives of WKCD are set out in Sections 4(1) and 4(2) of the WKCD Ordinance. In brief, the principal activities of WKCD are planning, developing, operating and maintaining the arts and cultural facilities, related facilities, and ancillary facilities of the District. Details of the principal activities of the WKCD's subsidiaries are set out in note 10 in the statement of accounts.

Statement of accounts

The results of WKCD and its subsidiaries (the Group) for the year ended 31 March 2021 and the state of affairs of WKCD as at that date are set out in the statement of accounts on pages 121 to 175.

Transfer to reserves

The Group's loss of HK\$869 million (2020: loss of HK\$604 million) was transferred to reserves. Other movements in reserves are set out in the statement of changes in equity.

Property, plant and equipment and intangible assets

Movements in property, plant and equipment and intangible assets during the reporting year are set out in notes 11 and 13, respectively, to the statement of accounts.

Capital

Details of WKCD's capital are set out in note 23 to the statement of accounts. Upon establishment of the M+ Collections Trust (the Trust) during the year ended 31 March 2017, WKCD made a contribution of HK\$1,214 million from its endowment fund to M Plus Collections Limited (a wholly owned subsidiary of WKCD) as the Trustee on behalf of the Trust.

西九文化區管理局

根據於2008年7月11日開始實施的《西九文化區管理局條例》(第601章)，管理局負責將西九發展成一個綜合藝術文化區。

董事局成員

主要業務

《西九文化區管理局條例》的第4(1)條與第4(2)條載列了管理局的職能及目標。簡言之，管理局的主要業務是規劃、發展、營運及維持西九的藝術文化設施、相關設施或附屬設施。管理局之附屬公司的主要業務詳情載於帳目報表附註10。

帳目報表

管理局及其附屬公司(本集團)截至2021年3月31日止年度之業績及管理局於該日的財務狀況載於第121至175頁之帳目報表。

撥入儲備的款項

本集團的虧損共8.69億港元(2020年虧損：6.04億港元)已撥入儲備內。儲備的其他變動載於權益變動表。

物業、廠房及設備及無形資產

物業、廠房及設備及無形資產於本年度的變動分別載於帳目報表附註11及13。

資金

管理局資金的詳細資料載於帳目報表附註23。隨著M+ Collections Trust(信託)於截至2017年3月31日止年度成立，管理局已轉撥一筆12.14億港元的金額予代表信託的受託人M Plus Collections Limited(管理局全資附屬公司)。

Directors liability insurance is in place to protect the Board and committee members of WKCD A against potential costs or liabilities arising from claims brought against them.

No contract of significance, to which WKCD A, or any of its subsidiaries, was a party and in which a member of the Board had a material interest, existed at the end of the year or at any time during the year.

Management contracts

No contracts concerning the management and administration of the whole or any substantial part of any business of WKCD A were entered into or existed during the year.

The statement of accounts was audited by PricewaterhouseCoopers, which was appointed by the Board in September 2020, in accordance with Section 29 of the WKCD A Ordinance.
